Rational

- Socioeconomic development in Africa is not only a priority for Egypt especially under its upcoming presidency of the African Union, but also poses a lucrative opportunity for businesses from the whole world.
- In that regards, Egypt is well positioned to take a leading role in promoting third country cooperation, mobilizing Arab investors and Arab Funds and technology and equipment providers from developed countries, which will be supported by the huge presence of Egyptian companies throughout Africa, low cost of its value added inputs, and free trade agreements with only 35% to 45% local content requirement.
- Ongoing examples include the new Tanzania dam and a host of power plants, roads, industrial, agriculture, health and touristic projects, all of which are with foreign partners.
- Moreover, Gulf investors along with Arab and Islamic development banks and funds, are now looking into Africa along with a host of bilateral, regional and multilateral donors and development banks.
- Accordingly, the 4th Egypt Investment Forum, shall be held with the slogan "Together for Africa", where matchmaking for blending of Egyptian, Arab, and African investors with global technology providers along with donors and development banks and funds shall be conducted.
- The event held under the Auspices of H.E. Abdel Fatah El Sisi, president of Egypt and during his presidency of the African Union, shall pave the way for such trilateral cooperation. Furthermore, the event shall coincide with general assemblies, boards and commissions of the Union of African Chambers, Union of Mediterranean Chambers, Union of Islamic Chambers, and bilateral Arab and African Chambers chambers of the Union of Arab Chambers shall ensure high level participation of key business leaders and multiplier organizations.
